- 13. That the arrangements for good drinking water shall be made available to all the studemts as well as the teachers and sanitary arrangement as per norms be made in the school.
- 14. That the school shall comply with norms of the CBSE for affiliation for examination purposes.
- 15. Medical facilities, leave, LTC, bonus, teaching allowances, CPF and other related facilities be provided to the staff as per Govt. norms.
- Provident Fund Register will be maintained and Cash Book completed and shown to the 16. E.O. of the Zone concerned for verification from time to time.
